5. FIRE-FIGHTING MEASURES

Specific hazards: Non-flammable material under ADG code

Special protective precautions and equipment: Not combustible, however following evaporation of aqueous component residual material can burn if ignited. On burning may emit toxic fumes. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

6. ACCIDENTAL RELEASE MEASURES
